**HATZ NORTH AMERICA
LIMITED ENGINE WARRANTY
FOR AIR & LIQUID-COOLED ENGINES
Effective February 2025**

HATZ NORTH AMERICA, a division of Hatz Americas, Inc., and its sister corporation, Motorenfabrik Hatz GmbH & Co. KG, hereinafter, jointly referred to as "HATZ", hereby grants a limited warranty on each new 4-cycle **Air-Cooled and Liquid-Cooled** diesel engine sold by Hatz to be free from defects in material and workmanship, under normal use and service, for a period of **twenty-four (24) months or 2,000 operating hours** (whichever occurs first) after the date of delivery to the original retail purchaser for Hatz powered equipment sold in North America.

For the Hatz **Air-Cooled engines**, an extended limited warranty is granted on the following items listed below for up to **thirty-six (36) months**, or a maximum **2500 operating hours**, (whichever occurs first), after the delivery date to the original retail purchaser.

For the Hatz **Liquid-Cooled engines**, an extended limited warranty is granted on the following items listed below for up to **thirty-six (36) months**, or a maximum **3000 operating hours**, (whichever occurs first), after the delivery date to the original retail purchaser.

Items covered in the 25th through the 36th months are limited to the following items: crankcase (excluding bearings), crankshaft (excluding bearings), connecting rods (excluding bearings), flywheels, cylinder head casting, gears (excluding bearings), and oil pump. Pursuant to this limited warranty, Hatz will, at their option, repair or replace at Hatz's headquarters, or at a point designated by Hatz, any part or parts which shall appear to the satisfaction of Hatz upon inspection at such point, to have been defective in material or workmanship. This warranty does not obligate Hatz to bear any transportation charges, travel expenses, or engine removal and reinstallation of the engine in connection with the repair or replacement of defective parts and such charges shall be borne by the original retail purchaser. Engines **not equipped** with hour meters will have the hours estimated based on a 35-hour work week.

In order to obtain service under this Warranty, the original retail purchaser shall give notice in writing to Hatz within (10) days of time that the defect becomes apparent. Hatz reserves the right to require that any engine upon which warranty service is sought be made available to Hatz, at Hatz's sales headquarters or a point designated by Hatz free and clear of any liens and other encumbrances on a timely basis. Repairs authorized by Hatz must be completed in a timely manner. Claims must be received at Hatz no later than thirty (30) days after engine repair date.

This Warranty shall not apply to any engine which shall have been installed or operated in a manner not recommended by Hatz, nor to any engine which shall have been repaired, altered, neglected or used in any way which, in the opinion of Hatz, adversely affects its performance; nor to any engine in which parts not authorized by Hatz have been used, which parts or use of which have damaged, caused defects in, or otherwise adversely affected the engine or its performance; nor to any accessories installed on the engine where the accessory manufacturer has its own warranty; nor to normal maintenance services or replacement or normal service items.

Hatz reserves the right to modify, alter and improve any engine or parts without incurring any obligation to replace any engine or parts previously sold without such modified, altered or improved engine or parts.

THIS LIMITED ENGINE WARRANTY, AND THE OBLIGATION OF HATZ HEREUNDER, ARE IN LIEU OF ALL OTHER WARRANTIES, EXPRESSED, IMPLIED, OR STATUTORY, INCLUDING ANY WARRANTIES OF MERCHANTABILITY OR OF FITNESS FOR A PARTICULAR PURPOSE, and all other obligations or liabilities, including actual, special, direct, indirect, incidental or consequential damages, lost profits, lost sales, lost time, lost use, or contingent liabilities arising out of the failure of any part to operate properly. No person is authorized to give any other warranty or to assume any additional obligation on behalf of Hatz unless made in writing and signed by an officer of Hatz.



HATZ NORTH AMERICA LIMITED PARTS WARRANTY FOR AIR & LIQUID-COOLED ENGINES

HATZ NORTH AMERICA, a division of Hatz Americas, Inc. and its sister corporation, Motorenfabrik Hatz GmbH & Co. KG, hereinafter, jointly referred to as "HATZ", warrants each new spare part sold by Hatz to be free from defects in material and workmanship, under normal use and service, for a period of six (6) months after the date of delivery to the original retail purchaser, and Hatz will, at their option, repair or replace at Hatz's sales headquarters, or at a point designated by Hatz, any part or parts which shall appear to the satisfaction of Hatz upon inspection at such point, to have been defective in material or workmanship. This Warranty does not obligate Hatz to bear any labor or transportation charges in connection with the repair or replacement of defective parts and such charges shall be borne by the original retail purchaser.

In order to obtain service under this Warranty, the original retail purchaser shall give notice in writing to Hatz within ten (10) days of the time the defect becomes apparent. Claims must be received at Hatz no later than thirty (30) days after part defect date.

This Warranty shall not apply to any parts which shall have been installed or used in a manner not recommended by Hatz; nor to any part which shall have been repaired, altered, neglected or used in any way which, in the opinion of Hatz, adversely affects its performance; nor to any part which is not a genuine Hatz part, the use of which will damage, cause defects in, or otherwise adversely affect the engine or its performance; nor to any accessories installed where the accessory manufactured has its own warranty; nor to normal maintenance services or replacement of normal service items.

Hatz reserves the right to require that any part upon which warranty service is sought be made available to Hatz, at Hatz's sales headquarters or point designated by Hatz free and clear of any liens and other encumbrances.

THIS LIMITED PARTS WARRANTY, AND THE OBLIGATION OF HATZ HEREUNDER, ARE IN LIEU OF ALL OTHER WARRANTIES, EXPRESSED, IMPLIED, OR STATUTORY, INCLUDING ANY WARRANTIES OF MERCHANTABILITY OR OF FITNESS FOR A PARTICULAR PURPOSE, and all other obligations or liabilities, including actual, special, direct, indirect, incidental or consequential damages, lost profits, lost sales, lost time, lost use, or contingent liabilities arising out of the failure of any part to operate properly. No person is authorized to give any other warranty or to assume any additional obligation on behalf of Hatz unless made in writing and signed by an officer of Hatz.



WARRANTY EXCLUSIONS FOR AIR & LIQUID-COOLED ENGINES

The following items will not be covered in the third year (25-36 months) under the extended limited warranty:

- Electrical / Electronic components
- Hoses
- Belts
- Adhesives
- Gaskets
- Hydraulic components
- Injection nozzles
- Gear cases and clutches
- Incidental expenses: travel time, mileage, and freight

ITEMS NOT COVERED BY WARRANTY FOR AIR & LIQUID-COOLED ENGINES

- Lubricants, fuels, shop towels, supplies and hazardous waste disposal
- Phone/Fax/Communication costs
- Rust or corrosion damage caused by algae and bacterial growth in fuel. Varnish forming in fuel system due to deteriorating fuel, seals, gaskets, etc. Steps to stabilize fuels should be considered to protect fuel injection equipment, especially when engines are not used daily.
- Any sales taxes
- Diagnostic and/or cleaning time. Exception: ½ hour labor will be allowed for HDS² diagnostic trouble shooting.
- Overtime labor
- Damage caused by the use of any starting aid or fluid
- Damage caused by pressure washing, steam cleaning or chemical washing
